Deadline: October 31, 2010

FEE: \$125 per booth for the 2-day show MUST accompany application forms. Cancellations will not be reimbursed after November 1, 2010.

BOOTH DIMENSIONS: Booth will be approximately 10-feet in length and 7-feet deep. Aisles will be at least 6-feet in width. The committee will assign booth spaces.

TIMES & SET-UP: Set-up will begin at 6 a.m. on Friday. Times of the show are 10 a.m. - 8 p.m. on Friday, and 9 a.m. - 9 p.m. on Saturday. There will be no disassembling of exhibits until 9 p.m. on Saturday night.

RESTRICTIONS: The Wings Over The Prairie Festival Arts & Crafts Show is juried. ONLY HANDCRAFTED items are to be sold. Absolutely no basic screen-printed items unless embellished by hand. The Stuttgart Chamber of Commerce reserves the right to approve any and all exhibitors and their articles sold to maintain a balanced variety of items sold. However, this does not guarantee exclusive right to any items sold.

NO SMOKING IN THE TENTS

PHOTO REQUIRED: A photo of your work MUST accompany the application or it will not be considered for approval. This applies to everyone including previous exhibitors. If a photo is not obtainable, a sample of the work can be substituted. Photos and samples will not be returned.

ELECTRICITY: The fee for special electrical needs is included in your booth fee. You will not be given a discount if you do not use. Please bring your own extension cords. No coffeepots, TV's or microwaves are allowed. ****ABSOLUTELY NO PERSONAL HEATERS ARE ALLOWED**** Heaters will be provided in tents if weather warrants.

LIGHTING: Moderate lighting is provided. You must provide lighting for your special needs.

SECURITY: Security will be provided only Friday night during non-show hours.

TABLES & CHAIRS: The Stuttgart Chamber has tables and chairs for rent. Tables are \$15 each and chairs are \$5 each for the two-day show. Payment should be included in your check. *Tables and chairs will not be available upon arrival unless reserved on application!*
