## Conditions

A. Exhibitors, employees and other representatives will comply with all general rules and regulations prescribed by the sponsor.

B. All installations erected by the exhibitor shall be subject to the approval of the sponsor.

C. Booth will be approximately 10-feet in length and 7-feet deep. Aisles will be at least 6-feet in width. Tent walls are 6-feet tall with poles every 10-feet down the center. The committee will assign booth spaces. If your booth will be taller than 6-feet, be sure to make special arrangements with Festival staff

D. Exhibitors shall not transfer or sublet the space or any part thereof or permit the same to be used by any other person without the prior written consent of the sponsor.

E. FEE: \$400 per booth for the 2-day show MUST accompany application forms. After October 30, 2020 the fee increases to \$425 per booth. Cancellation requests by October 30, 2020 will receive a full refund, less a \$50 processing fee. NO REFUNDS WILL BE GIVEN AFTER OCTOBER 30. NO exceptions.

F. The sponsor shall have full access to the space covered by this contract at all times.

G. Exhibitor will keep exhibits open throughout the entire event during the hours of 10 a.m. through 6:30 p.m. Friday, November 27, 2020 and 9 a.m. until 6:30p.m., Saturday, November 28, 2020. Dismantling of the booth or depletion of exhibits in any way shall not take place before the official end of the event without prior approval of the sponsor.

H. Exhibitor will indemnify and hold the sponsor harmless from all costs, losses, damages, or expenses including expense from litigation and attorney's fees resulting from any loss, injury or damage real or asserted, to any person or property arising out of any act or omission of exhibitor or his employees or other representatives. If requested, exhibitor will furnish sponsor with evidence that exhibitor has insurance in force with a reputable insurer, including coverage (with limits approved by sponsor) against contractually assumed liability. The Stuttgart Chamber of Commerce, its officers, agents, or members, the City of Stuttgart and the corporate sponsor shall not be held responsible for any loss or damage due to theft, fire, accident or other causes, but will use reasonable care to protect the exhibitor from such loss.

I. The exhibitor will completely set up his booth by 10 a.m., Friday, November 27, 2020, and will remove all property and all structures placed on the space by him and will surrender the space in the same condition, except for the natural wear and tear and damage not resulting from this contract, as at the beginning thereof. The area should be cleared at 10 p.m., Saturday, November 28, 2020, unless otherwise approved in advance by sponsor, and must be totally cleared by 12:00 midnight.

J Security will be provided by sponsor Thursday night, November 26, and Friday, November 27, from 8 p.m. to 9 a.m. Exhibitor must be responsible for his own booth during show hours.

J. Trademark Restrictions – 85th World's Championship Duck Calling Contest and Wings Over the Prairie Festival and its official logo is a registered trademark, and all exhibitors are prohibited from using this type of wording on any of its items to be sold in the commercial exhibit booths.
